Notice is hereby given by the undersigned Clerk of

Location Prior to Election Day: Chinook High School, 528 Ohio St. Chinook, MT. Hours: 8 AM-4 PM

Location on Election Day: Chinook High School, 528 Ohio St. Chinook, MT. Hours: 12 Noon-8 PM

Electors will consider the following issues at the election:

- Mill levy proposition to finance the school's **High School Technology Fund.**
- Mill levy proposition to finance the school's **Elementary School General Fund.**
- Mill levy proposition to finance the school's **Elementary Building Reserve Fund.**
- One (1) Trustee(s) to be elected for a three (3) year Term.

A qualified registered elector who will be absent from the district during the time the election is being conducted may: a) vote in person in the election administrator's office as soon as the ballots are available and until noon the day before the ballots are scheduled to be mailed; b) make a written request, signed by the applicant and addressed to the election administrator, that the ballot be mailed to an address other than the address that appears on the registration card. If you miss this regular registration deadline (30 days prior to the election), you may still late register at the county election office. The late registration certificate may be exchanged for a ballot at the school election administrator's office until the close of polls on election day.
